Despite positive signals on global steel production & capacity utilisation rates this year, seaborne iron ore prices are being dragged down by lower Chinese steel prices. Meanwhile, US tariffs are expected to cause a rise in scrap prices as a large portion of US scrap currently exported, is expected to stay in the US to cater for increased US steel output. On the other-hand, the worrying state of Turkey's economy and patchy demand for Turkish long products, seems likely to maintain downward pressure on scrap prices. Speakers will discuss the key supply and demand drivers for Chinese iron ore, and the global scrap market.

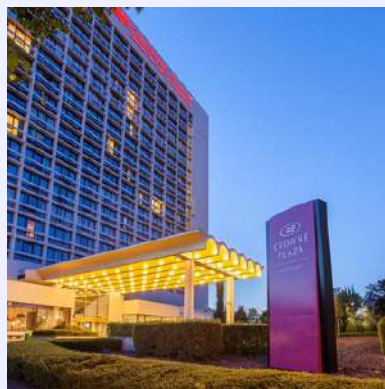

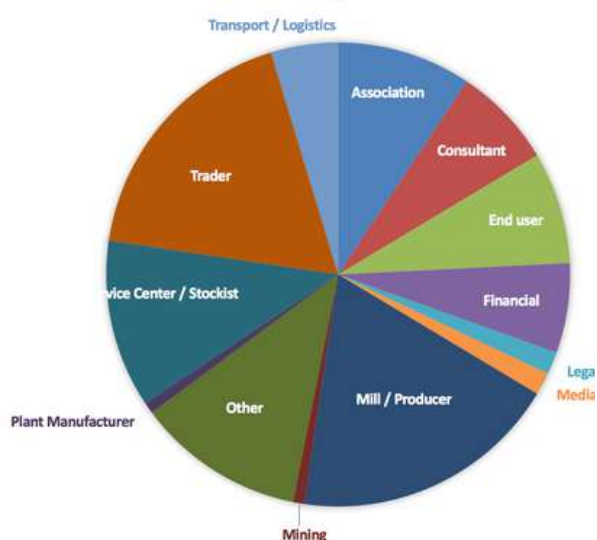

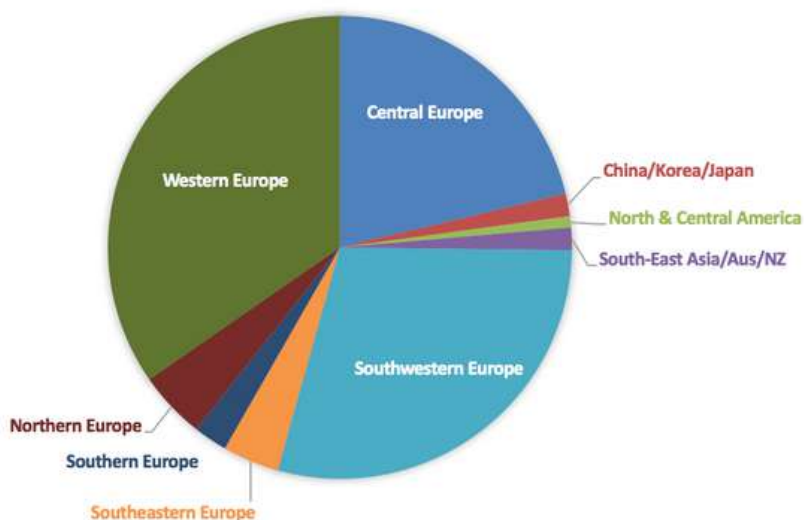
